All appropriate fields must be typed in CAPITAL LETTERS Incomplete or illegible forms will be discarded. Every effort will be made to inform you of such a decision.

- You are hereby applying for or renewing a membership with the Squamish Valley Rod and Gun Club.
- Acceptance is at the discretion of the Executive on behalf of the members.
- All memberships with SVRGC are personal. We do not have corporate or agency memberships.
- Failure to abide by Club Rules and Regulations will result in forfieture of your membership.
- Proof of residence is required for membership. A drivers licence or equivalent is adequate.
- Both a mailing and street address are required.
- Please enclose a PERSONAL CHEQUE with your completed form and mail via regular post.
- DO NOT send via registered mail.
- DO NOT send cash, certified cheque, bank draft or money order.
- Due to volume, memberships may take up to 30 days to process

#### **INSTRUCTIONS:**

An application form is required for each person applying for membership. All family members require a separate form. Select NEW or RENEWAL. If renewal, enter your previous membership number. Lapsed memberships are considered new, NAME - Type your legal name.

ADDRESS - Type in your **<u>street</u>** address (for insurance purposes) and **<u>mailing</u>** address - if different (to receive your membership).

EMAIL - Please enter a valid email address. This is used for sending you club information and updates.

PHONE - A contact number is required.

YEAR OF BIRTH - Please enter the year you were born. This is used for determining your membership type.

JUNIORS - Applicants under 18 years of age are required to have the form signed by a parent or Legal Guardian.

NEW MEMBERS require a sponsoring member. The sponsoring member must sign the application form.

Attendance at an orientation session is required for all **new** memberships. Re-orientation will be required on a periodic basis.

#### **MEMBERSHIP TYPES AND DEFINITIONS:**

RESIDENT - A person that resides within the District of Squamish. Proof of residence is required.

REGULAR: A person between the ages of 18 and 64

SPOUSE: A person cohabitating in a family relationship with a Regular member.

SENIOR: A person age 65 or older.

JUNIOR: A person 17 years or younger, not as a family member.

FAMILY: A combination of a Regular member, Spouse and their dependant children, under 18, living in the same residence

#### **RULES AND REGULATIONS:**

A copy of the Rules and Regulations is available on our website - svrgc.org Members are requested to carry a copy with them.

By submitting this application form, you state that you have read the Rules and Regulations and agree to abide by them.

All members are required to **SIGN IN** at the gate and **DISPLAY** their current membership card on their person while on club grounds.

Members are entitled to bring up to 2 (two) guests with them to the range, but are required to properly register them and pay the day fee. The guest's name, address and signature, along with the members name or number must appear on the envelope and be depositted in the day fee box. Members are responsible for their guests while they are on the club grounds and agree to supervise them 1 on 1 while handling firearms or bows.

Membership in the Squamish Valley Rod and Gun Club includes membership in the BC Wildlife Federation and all the benefits given their members, including BC Outdoors magazine, liability insurance, ATV/Snowmoblie liability insurance while actively hunting or fishing, discounts for extended ATV/Snowmobile liability coverage through Capri Insurance and discounts at some BCWF retailer members.
